Interest Rates and Interest Charges	
Annual Percentage Rate (APR) for Purchases	Your APR will be 11.25% to 17.90% . This APR will vary with the market based on the Prime Rate and your creditworthiness or other factors.
APR for Balance Transfers	Your APR will be 11.25% to 17.90% . This APR will vary with the market based on the Prime Rate and your creditworthiness or other factors.
APR for Cash Advances	Your APR will be 11.25% to 17.90% . This APR will vary with the market based on the Prime Rate and your creditworthiness or other factors.
How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you interest on purchases if you pay your entire balance by the due date each month.
