




## DATCU Online – Register for E-Statements

Follow these instructions to receive your DATCU account statements/notices electronically through mobile/online banking.

1. Go to [www.datcu.org](http://www.datcu.org). Log into your account, then select “**Statements**” from the menu bar on the left-hand side of the screen.



2. Select “**MANAGE PREFERENCES**” from the upper right-hand corner of the screen.



3. Under E-Statements Preferences, use the slider to select “**Enable All**”. You may also choose individual accounts from the menu if you do not want to register all accounts for E-Statements.





4. The “eStatement Disclosure Agreement” will appear. Click **“ACCEPT THE TERMS AND CONDITIONS”**.

Your periodic electronic statement will be available through DATCU Online.

eStatement Consent

By electronically confirming my request for eStatements, I authorize DATCU to set up my account to receive statements and other legal account notices electronically in lieu of paper. I further agree to and understand the following:

- This consent is to receive your statements electronically as well as other notices and tax documents as required by law.
- The electronic record accurately reflects the information found in the paper copy.
- You agree to no longer receive paper statements. You understand you will not receive a paper statement in addition to electronic statements.
- You have the right to withdraw your consent to receive your periodic statement electronically at no charge. Use DATCU Online or contact the credit union to cancel eStatements.
- It is your responsibility to inform the credit union of changes to your email address. You can change your email address in DATCU Online or by calling the credit union.
- You may receive a paper copy of your statement at your nearest branch or we can mail a copy to your address on file by calling 940-367-8585. There is a fee for us to print a copy of your statement for you. Please refer to the Truth in Savings Disclosure for fee.

Hardware and Software requirements are as follows: Personal computer or device, Internet Access, Adobe PDF Reader.
